## **Marriage Registration and Certification:**

### **Basic Information**

Registration of Marriage is being carried out under The Haryana Compulsory Registration of Marriage Act, 2008 and The Haryana Compulsory Registration of Marriage rules, 2008.

<b>Documents required for applying for Marriage Registration and Certification</b>
Affidavit of (a) Bride (b) Groom (c) Joint (Bride and Groom)
Statement (a) Bride (b) Groom (c) Bride's Father/Mother (d) Groom's Father/Mother (e) Two Local Witnesses (individual, not in blood relation)
Date of Birth proof of both Husband and wife (School Certificate, Birth Certificate Medical certificate indicating age or an affidavit/self declaration affidavit notarized regarding age only in cases when birth & school certificates are not available.)
Address Proof bride and groom (Voter ID Card, Ration Card, Aadhaar Card, Passport, Driving License) <b>If Haryana Resident Then Only AADHAAR CARD is Mandatory</b>
Marital Status at the time of Marriage mention in Application Form
Proof of Residence of Parents of both (Bride & Groom) and Witnesses (Voter ID Card, Ration Card, Passport, Driving License etc) <b>If Haryana Resident Then Only AADHAAR CARD is Mandatory</b>
Passport sized photographs of all six members (a) Bride (b) Groom (c) Bride's Father/Mother (d) Groom's Father/Mother (e) Two Local Witnesses (individual, not in blood relation)
Marriage Invitation Card of Both Sides
Certificate of marriage if marriage is performed in Gurudwara or Mandir (Regd.)
Minimum four marriage ceremony photographs preferably of <b>Phere, Family of both Bride &amp; Groom, Jaimala, Pandit</b>
Five photographs of couple of size 3"X2" (Bride and Groom jointly) of simple & same photo
Hotel/ banquet hall bill (if marriage took place at Hotel/ Banquet Hall)
Attested copy of divorce Decree/ order in case of a divorcee and Death Certificate of spouse in case of widow/ widower. Kindly bring the original Certificate while visiting the CFC.
In case of marriage of any Indian Citizen with a person having a foreign citizenship, domicile verified from the embassy/High Commission of the country which he/she claims to be the citizen of, is required.

**Note: - Please take manual appointment for Witness/Appointment from Marriage Registrar after submission of manual file if Applying for Marriage registration after 90 days of Marriage**
